### Race to the Slide Conditions

The Race to the Slide will be held prior to the Million Dollar Competition at The Run for a Million on Saturday, August 15.

The event will be open to horses of all ages and breeds and those horses will be shown in Western attire. Horses need not have an NRHA Competition License, but riders must be a member of one of the Associations or Organizations represented at TRFAM (NRHA, NRCHA, NCHA), or one of the Heritage Ranch Challenge contestants.

This event will feature \$70,000 in added money. The entry will be \$1,000. Entries will be limited to fit production schedule of TRFAM, so enter early.

#### Scoring Criteria

The highest scoring entry will win.  
 Score = Slide Length (in feet) + Speed (in mph)  
 Example: 28 ft slide + 23 mph = 51 points

In addition to the regular payout, the entry with the fastest rundown will receive \$10,000, and the entry with the longest single slide mark will win \$10,000.

In the event there is a tie for the Championship, the tied entries will compete in a "Slide Off" with the same rules.
